How do I report that I or someone known to me was abused by a priest or someone connected to the Church?

If you were abused by a priest or someone connected with the Church in the Diocese of Clogher, or if you know or suspect that someone else was abused, you can report it to the **Diocesan Designated Liaison Personnel (DLP)**, Brendan Kelly, Anne Molloy or Martha Smyth

MAKING CONTACT WITH THE DESIGNATED LIAISON PERSON

What to do if you have a concern or suspicion or wish to make an allegation of abuse which has occurred against a child, young person or vulnerable adult.

The Diocese of Clogher takes seriously all allegations, suspicions or concerns of abuse – but especially those which relate to the abuse of a child, young person or vulnerable adult which are made against any member of the clergy, staff or volunteers. The Diocese has appointed three Designated Liaison Persons whose role it is to process all allegations of abuse brought to the attention of the Diocese.

As an adult, if you have been abused as a child or you have a concern about a child, young person or vulnerable adult, there are several options where you can seek advice or where your concerns can be addressed. You can contact any or all of the following:

- The Church via the Designated Liaison Persons
- Police – PSNI (Northern Ireland) or An Garda Síochána (Republic of Ireland)
- Health and Social Care Trust (Northern Ireland) or Tusla (Republic of Ireland).

If you choose to contact the **Diocese's Designated Liaison Persons**, he/she will undertake the following steps:

1. Gathering Information:

- Collate the information you wish to share
- Make a written account of this information (this is not a formal statement) and share this with you to ensure accuracy
- Explain that all relevant information must be referred to the relevant police force, and, if appropriate, to the Social Care Trust (Northern Ireland) or Tusla (Republic of Ireland) or both.

2. Provision of Support:

- Offer you support which can include any or all of the following:
 - i. Counselling – the Church has contracted an independent counselling service, “Towards Healing”, which can be contacted directly by you. This is a totally confidential service.
 - ii. Provide information on how to access other organisations that may be suitable to provide the kind of support you need
 - iii. An identified person, appointed by the Bishop, known as a Support person - this is not the Designated Liaison Person. The role of the Support Person is to assist with communication between you and the Designated Liaison Person; to facilitate you in gaining access to information and help; and to represent your concerns during the inquiry process. The Support Person must not act as your counsellor or therapist but may consider how your therapeutic or spiritual needs may be met whilst being mindful of your on-going vulnerability during this process. The Support Person will consider your wishes regarding disclosure of abuse, in regard to a pastoral response by the Church to your family. He/she should be available to you throughout the course of the inquiry process and thereafter as required. They should ensure that you are kept informed of developments in relation to you and represent your wishes and any therapeutic needs to the Designated Liaison Person as required. If you consider it helpful, the Support Person can arrange a meeting between you and the Bishop. Under no circumstances will the same Support Person be provided for you and for the respondent.

3. What Happens Next?

Once the information has been referred to the relevant Statutory Authority, the Designated Liaison Person will:

- i. Inform the Bishop that an allegation has been received and that a file record has been created

- ii. Liaise with the relevant Statutory Authority to ensure the appropriate exchange of relevant information. The Designated Liaison Person is not involved in any statutory investigation of the allegation

- iii. Make contact with the person (respondent) against whom the allegation has been made. The timing of this meeting will be determined by the police and will outline the following:
 - a) That an allegation has been made, and if agreed with the relevant police force, who made the allegation; and
 - b) What information can be shared with the respondent – again to be determined by the relevant police force

Given the complexities of some allegations, this process can be lengthy and may take some time to complete

What if you are unhappy with how your concern/allegation has been dealt with?

If you are unhappy with the way in which your concern/suspicion/allegation has been dealt with by staff within the Diocese, the National Safeguarding Office for Children in the Catholic Church has a procedure to address such complaints. What will happen if I report abuse?

Reporting abuse is always difficult. We will try to make it as easy as possible for you. Normally we will meet with you to hear your account of abuse. We will discuss and agree with you where the meeting should take place. We can meet you in our offices but if that is inconvenient or otherwise difficult for you we can arrange to meet in a place of your choosing. If you do not want to meet us, we will take your complaint over the phone, by letter or in an e-mail.

Can I report abuse in confidence?

Any information that you share with us will be treated with the utmost respect and only shared with the people who need to know it. We are required to share information about abuse with the civil authorities, that is, the PSNI & Gardai as well as Tusla, the Child and Family Agency, or the relevant Health and Social Care Trust. We also need to share the information with some colleagues in the Diocese. If you tell us that you were abused by a person who is still alive, we will put your complaint to that person in order to get their response to it.

We will explain all of this to you when we hear from you and before you tell us about the abuse so that you can make an informed decision about sharing your information with the us.

What support will I be offered?

We will put you in touch with Towards Healing. This is an organisation that provides a range of services to people who were abused by priests and religious and for their families. One of the services they provide is counselling. The service is free and there is no waiting list.

The Designated Liaison Person (Brendan/Anne/Martha) will also keep in touch with you to let you know how the Diocese is dealing with your complaint, if that is your wish. Alternatively, you will be offered the assistance of a Support Person to accompany you through the process of dealing with your complaint if that is your preference.

What if I do not want to report abuse to the Diocese?

You can take your complaint directly to the PSNI/Gardai or to Tulsa, the Child and Family Agency (ROI) or the relevant Health and Social Care Trust (NI). These Telephone Numbers are listed above. If you are unsure who to approach we can assist you with this.

If the allegation relates to church personnel in the Diocese of Clogher, it would be helpful if you let us know that you have reported this matter to the PSNI/Gardai.

What if the person that abused me was not a priest or in any way connected with the Church?

If you are having any difficulty finding out who you should contact, we will be happy to advise you.
